


#### Introductions

Those present shared current education topics they were interested in learning more about in the upcoming days and which they thought were most important during this legislative session.


The group discussed each slide topic and asked questions pertinent to each.

## **Student Enrollment**







# Concord Enrollment




# 10 Year Enrollment History

Assistant Superintendent Donna Palley presented highlights of the district's initiatives.

- PACE Performance Assessment for Competency Education
- STEAM Science, Technology, Engineering, Arts, Mathematics
- Technology 1:1 Chromebooks for 9th & 10th Graders
- CHS Help Desk students helping students
- Performing Arts Theater, Chorus, Band
- Science Program Pilot

#### Early Childhood Study

Superintendent Forsten noted that the essential question that is being addressed by the administration and School Board is this: "What are the best practices in kindergarten programming and how do these practices connect with early childhood programs in our school community?"

Currently, the School Board is considering two options for 2017-2018: full day kindergarten for all students for an estimated \$1,211,565 cost for the first year; and half day kindergarten for 2/3 of eligible students and full day kindergarten for 1/3 of eligible students for an estimated \$386,475 cost for the first year.

### Steam to Gas Conversion

The conversion to natural gas from steam heating due to the closure of Concord Steam affects four schools (Concord High School, Rundlett Middle School, Abbot-Downing School and Christa McAuliffe School). Due to the very short timeframe, this is an emergency process for the district, and has resulted in the necessity of bonding \$9 million to cover the immediate costs.

## Rundlett Middle School Study

Superintendent Forsten and Director of Facilities Matt Cashman discussed the progress of the Rundlett Middle School Study, which includes educational specifications as well as architectural studies of the existing structure. This study was awarded to HMFH Associates, which served as the architectural firm for the construction of the three new elementary schools. The firm made a presentation to the School Board and the community the previous evening.

Financial Impacts on the Budget 2018

- Steam to gas conversion
- New Hampshire Retirement System (over \$700,000 increase)
- Special education contracted services
- Special education individual Educational Assistants
- Special education out-of-district tuition
